When will a decision be made?

Funds are allocated as donations and sponsorship by Tullamore Credit Union. A presentation night will be held in April 2017 and the results will be announced at the presentation.

When will I be notified?

Results will be announced at the presentation night. An invitation will be issued to the contact person named on the application form.
